The Lima Mbeu Multi Asset Fund is an actively managed fund which aims to deliver capital growth over the long term. The fund invests in a diversified mix of domestic and foreign asset classes.

The fund is suitable for investors who are looking for long term growth of capital but with lower risk relative to an investment in equities. The fund is suitable for investors that have an investment horizon greater than 5 years but prefer a sophisticated investor to make the asset allocation decision on their behalf.

Investment objective

Our objective is to deliver total returns that are consistent whilst outperforming a composite Multi-Asset benchmark over a 3 year investment horizon.

We construct the fund in a risk-controlled manner with the aim of delivering investment returns that are greater than benchmark, but with lower volatility.

Investment philosophy

Our belief is that diversified growth investing is one of the best ways to build wealth consistently with low volatility.

Tactical asset allocation can enhance investment returns as asset classes respond differently to different economic drivers.

We believe that our selection of growth companies can further enhance investment returns by outperforming the the equity component of mulit-asset benchmark.
